

Official Contest Rules – KQUR – Bigote de Pepe

1. **NO PURCHASE NECESSARY TO PARTICIPATE OR WIN. VOID WHERE PROHIBITED, SOME RESTRICTIONS APPLY. Open to Laredo residents only.**
2. **SPONSORS:** Radio United, LLC, including station **KQUR Digital 94.9"** located at **107 Calle del Norte Rd Suite 212, Laredo, Texas 78041** (the "Station"). The administrator of the Contest is **Radio United, LLC**.
3. **DATES OF THE CONTEST:** Bigote de Pepe " (The "Contest") begins on Monday June 28th, 2021 and ends on Friday July 9th, 2021. Specific times and locations will be announced on-air.
