

## Official Contest Rules – KQR – La Loteria Del Barrio

- 1. NO PURCHASE NECESSARY TO PARTICIPATE OR WIN. VOID WHERE PROHIBITED, SOME RESTRICTIONS APPLY. Open to Laredo residents only.**
- 2. SPONSORS:** Radio United, LLC, including station **KQR Digital 94.9"** located at **107 Calle del Norte Rd Suite 212, Laredo, Texas 78041** (the "Station"). The administrator of the Contest is **Radio United, LLC**.
- 3. DATES OF THE CONTEST:** La Loteria Del Barrio " (The "Contest") begins on February 19<sup>th</sup>, 2021 and ends on March 25<sup>th</sup>, 2021. Specific times and locations will be announced on-air.
- 4. ACCEPTANCE OF OFFICIAL RULES:** By entering, you agree to be bound by these official contest rules (these "Official Rules"). - 5. HOW TO ENTER/PLAY:** To become a qualifier: Participants must listen to Digital 94.9 or watch Telemundo to look for clues "La Tarjeta Del Dia" Monday – Wednesday and gather a total of 3 clues. On Thursday at 9 am, participants must text the word "Loteria" to "69491" and a participant will be chosen randomly, Dj will call participant to see if all 3 clues were gathered.
- 6. PRIZES:** There will be a total of **TWO (2)** prize winners (**ONE (1)** per week). Prize consist in a \$225 Visa Gift Card.
