

Official Contest Rules – KNEX/KQUR – Pick Your Purse!

- 1. NO PURCHASE NECESSARY TO PARTICIPATE OR WIN. VOID WHERE PROHIBITED, SOME RESTRICTIONS APPLY. Open to Laredo residents only.**
- 2.
